If you weren't at the March, 2015 SMSC Board of Directors' meeting, then you missed the following:

SMSC is now the sponsor of a high school youth trap team for the spring of 2015, to encourage youth to become safely involved in shooting sports as a result of a request from SMSC Trap Club.

SMSC Education has been disbanded. The former SMSC Education team will operate independently of SMSC, and now have a new name: Safety Strategy Training, Inc.

Permit to Carry will be offering Concealed Carry training at Scheels. They petitioned SMSC to use SMSC's range for the live-fire portion of their class. The BoD has approved this request.

Chandler's Conceal and Carry requested approval to use the SMSC range (and, perhaps, the classroom) for future live-fire class activities. Given the sudden interest in using the club for firearms educational purposes, the BoD agreed to consider this request. There is no decision for this particular team yet, but **the Board has** placed the following restrictions on firearms education activity at SMSC:

• A maximum of 4 commercial range sessions will be permitted on the pistol range in any month. Only two of these range sessions may be on weekends. If there are two sessions on weekends, the weekend days must alternate between Sat & Sun, and cannot be same weekend (i.e., only four hours on one Saturday and four hours on one Sunday may be "tied up" by education classes each month.)

• Pistol range will be closed to members during qualification time for classes. Details to be posted on the club on-line calendar. Members may use the 25-yard range during class activities on the pistol range, but not at any other times.

• Requests must come to the BoD at regular BoD meetings. First-come, first-served general guideline, moderated at BoD's discretion. Can schedule activities up to 3 months from current BoD meeting date. Any single group can reserve no more than 2 sessions per month.

• Commercial (non-club) groups must pay \$140 for classroom use, as previously set out.

• There is a \$50 non-refundable reservation/outdoor range use fee, which must be paid at the time the reservation is made, plus \$10 each student for a maximum of 4 hours use of entire handgun range. If the range is in use longer than 4 hours, additional charges will apply.

- The commercial group must be: licensed, bonded, insured, and use NRA certified instructors.
- SMSC must be a named insured on the policy.
- SMSC reserves the right, and must be permitted, to send 3-4 BoD members to review the educator's class.

• SMSC reserves the right to review/observe the range activities of all range users at any time, at SMSC's discretion.

• All club functions must be open to all members of the club.

Please review the updated Standard Operating Procedures (SOPs) for the SMSC range. New ones have been printed and will soon be posted. You should review these each time you use the range.

You are now able to unsubscribe from emails from SMSC. WE HOPE YOU WON'T. E-mail is now the OFFICIAL SMSC communication method. If a member opts out of email communications, important information like membership renewal notifications, BoD meetings, BoD meeting summaries (this note), agendas, and notices for future BoD meetings will not be received.

Bicycle trail construction will begin soon, along the road in front of SMSC. Please be careful when entering the site during construction, and give the work crews your full cooperation and courtesy. Construction should be completed by June 1, 2015.

SMSC is for the use of members only. A single escorted guest may accompany a member for no additional charge. Additional guests must purchase a daily pass (\$20 each). Guests are the responsibility of the escorting member, and must follow all SMSC rules and the SOPs posted at the range. Guests must leave when the escorting member leaves. Unsafe conditions will not be tolerated. Members and guests may be asked to leave

the range if rules violations or unsafe conditions are observed. Do not let anyone, other than your personal guest, through the gates.
