#### **RULES FOR NOMINATIONS:**

- 1. No nominations will be accepted during the meeting, in December.
- 2. All nominations must be received by the Board <u>before</u> the end of the November 10 Board meeting. (Nominations will be accepted during the September 8 and November 10 Board Meetings. Both of these Board Meetings will be held at the SMSC Clubhouse, at 7:30PM.)

  RULES FOR NOMINEES:

# 1. The nominee must agree to run for the Board BEFORE being nominated. Nominees not present, when the nomination is made, should expect to be contacted by a member of the Board to confirm their agreement to run for the Board.

2. Nominees should be prepared to speak, for 2 minutes or less, regarding their qualifications, interests, area of service, and expected contribution to the leadership of the club, at the November 17 All-Member meeting. If prior commitments preclude the nominee's participation at this meeting, the nominee should designate a representative to read their written statement.

#### **EXPECTATIONS FOR THOSE ELECTED:**

- 1. Participate in all SMSC Board meetings and activities.
- 2. Contribute to the SMSC in a positive way.
- 3. Invest time and labor in supporting SMSC and its members.
- 4. Assume a position of responsibility and service on the SMSC Board.

**SMSC Bullseye league begins Tuesday, September 6th,** with three weeks of organized practice. The first two practice weeks include a brief orientation class at 6:15PM, in the SMSC clubhouse. This orientation class is mandatory for new shooters. We ask new shooters to come to the training weeks to: ask questions, gain practice and confidence, establish average score - used to determine their handicap.

League shooting begins Tuesday, Sept. 27, at 6PM, at the SMSC indoor range, and goes for 10 weeks. Shooting ends when everyone has completed their round of fire (usually about 9 PM). Shooters need not attend every week; you can shoot multiple times in an evening to 'shoot ahead,' and there are ways for a shooter to "make up" a missed week.

Anyone interested in, or curious about, precision pistol shooting is invited to attend an orientation class to find out what Bullseye League is all about. The only requirement to join the Bullseye league is that you are an SMSC member in good standing. You do not need to have equipment. The Bullseye League has guns, eye and hearing protection, and you can purchase the needed .22 ammunition from the club.

<u>DO NOT LET ANYONE THROUGH THE GATE WITH YOU</u>, either coming in or going out, other than your immediate family or your ONE personal guest. <u>Every member must badge in and out.</u> Your SMSC ID badge should be visibly displayed at all times inside the fenced-in (range) areas.

Eye and ear protection is required at all times for everyone inside the fenced-in area.

EVERY member is responsible to know, follow, and enforce firearms safety and all posted rules at all times.

Change in membership details: The Board has clarified membership details, as follow: Membership is for the member ONLY. The member's spouse or partner, sharing the same address, per information on their driver's licenses, and their children or grandchildren under age 18, living at the same address, are allowed on the range with the member for no additional charge. Spouses or partners, with the same address, may have their own badge for range access if they pay the badge fee (\$10), completing the Safety Orientation, and provide a completed Waiver.

Club Guest WiFi Password is "clubhouse" (without quotation marks).

You are responsible to keep your email address current. The club uses email and the web site (<a href="www.smsclub.org">www.smsclub.org</a>) EXCLUSIVELY to communicate with members. If your email address changes, please notify us via email at <a href="clubmail@smsclub.org">clubmail@smsclub.org</a>. We use email to notify members of their renewal date. If you do not have a valid email address on file, you will NOT be notified. This newsletter is also emailed, and it is published on the web site. It contains information you need to know. Without email, you must go to the club's web site to stay current on important club business, rules, etc.

**Safety Orientation class** dates and times are on the calendar at <a href="www.smsclub.org">www.smsclub.org</a>. Classes are not necessarily always on the same day each month, nor will classes always be held at the same time.
